

IMPORTANT INTERNAL CIRCULAR

Sub.: Authentic intimation regarding Peer Team of NAAC visit from 27th, 28th February 2017 and 1st March 2017.

Ref.: Letter No. NAAC/NR-KR/PTV(RJUNGN11331)/2017, dated 13th February 2017 received from Dr. (Mrs.) K. Rama, Adviser, NAAC.

The University administration is pleased to notify in reference to the Accreditation (Cycle-1) of our University by NAAC that the high-level Peer Team headed by Prof. R.C. Sobti (Former Vice-Chancellor, Panjab University) and currently Vice-Chancellor, Babasaheb Bhimrao Ambedkar University (Central University), Vidya Vihar, Rai Bareilly Road, Lucknow-226 025, Uttar Pradesh – as its Chairperson, and comprising of other senior level distinguished academicians, is scheduled to visit the University from **27th, 28th February 2017 and 1st March 2017**. Dr. (Mrs.) K.Rama, Adviser NAAC, will be coordinating the visit from NAAC.

It is to further notify in terms of “Guidelines to the Institutions by **National Assessment And Accreditation Council** (Effective from 1st April 2007)”, and with a view to generate adequate publicity about the visit of the Peer Team to the staff of the University, and accordingly indicated that NAAC is an autonomous organisation established in 1994 by the University Grants Commission (UGC) with headquarters at Bangalore; and that the institution, (Suresh Gyan Vihar University, Jaipur, Rajasthan), has volunteered for Assessment and Accreditation by NAAC. Consequently, a Peer Team comprising of eminent academic experts as mentioned above will be visiting the institution to acquaint themselves with the strengths and weaknesses of the institution with reference to quality assurance. The visit is neither an inspection nor an attempt to solve any grievances. The whole process is to validate the Self-Study Report and help the institution in quality assurance.

As already conveyed during repeated orientation sessions for this purpose, the Team is visiting the University after a thorough study and analysis of the SSR provided by the institution. The purpose of the visit is to validate the claims of the institution as detailed in its Self-Study Report, through interactions, inferences and checking relevant documents. Further, the Peer Team will look for evidences, to understand the “collective impact” of the faculty and the institutional ambience, on the educational experience and outcome of the students.

All the Heads of constituent Schools and major departments / academic departments have already been familiarized with the time-schedule of the visits. During the visit, each Head of the Department/ or the Dean of a faculty shall present in brief, the highlights/ achievements of the concerned department/s during the general meeting of all the academic heads. The Peer Team in its wisdom may visit only select departments, based on their study of the departmental profiles.

All concerned members of SGVU Team including the students, may take a conscious notice of this important Circular.
